Public Comment:

Commissioner Benner informed the public that Perry and Juniata County residents needing emergency services are now able to text their situation to dispatchers at the Perry County and Juniata County 911 Centers.

Marla Steele asked Commissioners if they are considering helping to fund the Veterans Memorial and park located in Marysville.

Approval of Minutes: Commissioner Naylor made a motion to approve the minutes of April 16, 2018. Commissioner Benner seconded the motion. All agreed. Motion carried.

Warrant List: Commissioner Naylor made a motion to approve the warrant list for the week of April 23, 2018 in the amount of \$245,468.60. Commissioner Benner seconded the motion. All agreed. Motion carried.

Commissioner Naylor made a motion to approve the contract with Com-Pro's in the amount of \$238,216.00 for Perry County and \$216,183.00 for Juniata County. Commissioner Benner seconded the motion. All agreed. Motion carried.

Commissioner Naylor made a motion to approve the Community Development Block Grant Program in the amount of \$235,878.00 to the Department of Community and Economic Development for contract year 2018. Commissioner Benner seconded the motion. All agreed. Motion carried.

Based on the recommendation of Cumberland /Perry Drug & Alcohol Commission, Commissioner Naylor made a motion to approve a contract for expenses up to \$41,892. for Single County Authorities to work with Veterans who have PTSD and Substance Use Disorder.
