Commissioner Benner opened the meeting at 10:00 AM on December 10, 2012 with the Pledge to the Flag and a moment of silence.

**Public Comments:** None.

Commissioner Rudy made a motion to approve the minutes of December 3, 2012. Commissioner Naylor seconded the motion. Motion carried.

Commissioner Naylor made a motion to sign the warrant list in the amount of \$84,696.06. Commissioner Rudy seconded the motion. Motion carried.

Based on the recommendation of Pennoni Associates Inc., Commissioner Naylor made a motion to approve a contract change order for Redrock Construction who does the maintenance repairs for the County Bridges. The sum of \$6,224.56 is deducted from the total adjusted contract price of \$30,841.03. Commissioner Rudy seconded the motion. Motion carried.

Commissioner Rudy made a motion to approve the 2012-2013 "Accountability Works Community Service Program" in the amount of \$10,000. Commissioner Naylor seconded the motion. Motion carried. The term of the Agreement is April 1, 2013 through March 31, 2014. Perry Human Services implements this program on behalf of the county and the juvenile probation office.

Based on the recommendation of Lori Lower, Children & Youth Director, Commissioner Naylor made a motion to approve a Purchase of Service Agreement with PA Child Corporation to provide child welfare services in the amount of \$42.55-\$86.89 for placement and non-placement services. Commissioner Rudy seconded the motion. Motion carried.

Based on the recommendation of Tom Bell, 911 Director, Commissioner Naylor made a motion to approve a 9-1-1 Inter-County Call Handling Agreement with Cumberland County. This allows telephone exchanges within Cumberland and Perry County that serve geographical areas of both counties. Commissioner Rudy seconded the motion. Motion carried.

**Employee Status:** Commissioner Rudy made a motion to accept the letter of resignation for Angela Bates, Conference Hearing Officer, Domestic Relations, effective December 5, 2012. Commissioner Naylor seconded the motion. Motion carried.

Commissioner Rudy made a motion to accept the letter of resignation for Clark Steele, Corrections Officer, effective December 24, 2012. Commissioner Naylor seconded the motion. Motion carried.
