Commissioner Benner opened the meeting at 10:00 AM on June 10, 2013 with the Pledge to the Flag and a moment of silence.

**Public Comment:** None.

Commissioner Naylor made a motion to approve the minutes of June 3, 2013. Commissioner Rudy seconded the motion. Motion carried.

Commissioner Rudy made a motion to approve the warrant list in the amount of \$80,599.41 for the week of June 3, 2013. Commissioner Naylor seconded the motion. Motion carried.

Commissioner Rudy made a motion to approve the fare structure that is being submitted to PennDot for the coming year. Ecolane is requesting fare structures to be changed from zones to mileage trips. Commissioner Naylor seconded the motion. Motion carried.

The Commissioners donated a Perry County Transportation Van with approval from PennDot to the Disabled American Veterans (D.A.V.) for trips to medical appointments for veterans in the County. The D.A.V. currently transports 78 veterans in a five day period for appointments to Pittsburgh, Philadelphia, Baltimore, Hershey, Camp Hill and Lebanon. Commissioner Naylor thanked Stacey Nybeck, transportation director, for working with PennDot to accomplish this service.

Based on the recommendation of Cumberland Perry Drug and Alcohol Commission, Commissioner Naylor made a motion to approve the following contracts:

- **Libertae, Inc.** Non-hospital treatment state wide rate 7/1/13-6/30/14
- **NHS, Stevens Center** Outpatient services maximum amount of \$17,000 7/1/13-6/30/14

Commissioner Rudy seconded the motion. Motion carried.

Based on the recommendation of Jack Carroll, Cumberland Perry Drug and Alcohol Commission, Commissioner Naylor made a motion to appoint Misti Mack to a three-year term from July 2013 through July 2016 to fill a vacancy on the Drug and Alcohol Commission Community Advisory Board. Commissioner Rudy seconded the motion. Motion carried.

Commissioner Rudy made a motion to approve the Agreement with the Retired and Senior Volunteer Program (RSVP) of the Capital Region Inc. to provide a summer program for students from grades 1 through 8 of the Newport School District. Perry County Children and Youth Services Agency has agreed to financially support the Newport Summer Zone Program in association with truancy prevention in the amount of \$50,000. This Agreement is in effect from June 1, 2013 through August 30, 2013. Commissioner Naylor seconded the motion. Motion carried.
