Commissioner Benner opened the meeting at 10:10 AM on June 23, 2014 with the Pledge to the Flag and a moment of silence. Because of the anticipated attendance the meeting was held in the courtroom.

Commissioner Rudy made a motion to approve the minutes of June 16, 2014. Commissioner Naylor seconded the motion. Motion carried.

Commissioner Naylor made a motion to approve the warrant list in the amount of \$124,690.24 for the week of June 23, 2014. Commissioner Rudy seconded the motion. Motion carried.

Commissioner Naylor made the motion to approve the agreement in the amount of \$37,500 annually for a two-year period with Mission Critical Partners. Mission Critical Partners will provide support related to network evaluation and configuration, migration, transition and negotiations to streamline public safety telecommunications.
