Commissioner Benner opened the meeting at 10:00 AM on June 30, 2014 with the Pledge to the Flag and a moment of silence. Because of the anticipated attendance the meeting was held in the Annex Building.

**Public Comment:** Charles Brown asked for an update on the Auditors. Commissioner Benner responded that Robert Morris, CPA conducted a review of the sheriff's records for licenses to carry firearms permits and is willing to conduct an audit of the permits and certify his findings.

Commissioner Naylor made the motion to promote Maggie Gouse from a grade 8 fiscal/commissioners assistant to a full time fiscal assistant grade 10, effective July 14, 2014. Commissioner Rudy seconded the motion. Motion carried.

**Solicitors Report-** Nothing that required Action. Solicitor Bunt informed the public that Robin Holman Loy, Sheriff's Solicitor, requested in writing that insurance coverage is not provided to the sheriff because of the claim being brought on behalf of one elected official against another elected official. The solicitor explained this means that defense money for the sheriff would come out of the County Budget.
