Commissioner Benner opened the meeting at 10:00 AM on May 9, 2011 with the Pledge to the Flag and a moment of silence.

**Public Comments:** None.

Commissioner Naylor made a motion to approve the minutes of May 2, 2011. Commissioner Amsler seconded the motion. Motion carried.

Commissioner Amsler made a motion to sign the warrant list in the amount of \$144,069.05. Commissioner Naylor seconded the motion. Motion carried.

Based on the recommendation of Cumberland Perry Drug & Alcohol Commission, Commissioner Naylor made a motion to approve the American Lung Agreement. Commissioner Amsler seconded the motion. Motion carried. The Drug & Alcohol Commission receives funding from the American Lung Association to provide tobacco prevention services and school based youth tobacco cessation services to residents of Cumberland and Perry County. The term of the Agreement is from July 1, 2011 through June 30, 2012. The agreement amount is \$25,000 for Cumberland County and \$10,000 for Perry County.

**Employee Status:**

Based on the recommendation of Warden Yeingst, Commissioner Naylor made a motion to change the status of Eric Swope from a part time corrections officer to full time effective May 8, 2011. Commissioner Amsler seconded the motion. Motion carried. Salary Board will be held at a later time.

Based on the recommendation of Judge Morrow, Commissioner Naylor made a motion to hire Nicholas Peachey as part time law clerk. Commissioner Amsler seconded the motion. Motion carried. \$10.00 hourly, effective May 23, 2011 for a 20 hour work week.

Based on the recommendation of Judge Morrow, Commissioner Naylor made a motion to hire Evan Jones as part time law clerk. Commissioner Amsler seconded the motion. Motion carried. \$10.00 hourly, effective May 23, 2011 for a 30 hour work week.
