Commissioner Rudy made a motion to approve the Grant Application for RRA/Byrne Justice Assistance in the amount of \$1,742. Commissioner Naylor seconded the motion. Motion carried. This grant is for the purchase of office supplies, computers and support equipment. Each Probation/Parole office will be trained on the Livescan equipment to register sex offenders as they apply to the Adam Walsh/Soma Act. The probation department will be responsible for the registration process for current sex offenders on Supervision on December 20, 2012 and all sentenced sex offenders thereafter.

Employee Status: Based on the recommendation of Michelle Harris, Commissioner Naylor made a motion to approve the hiring of Helen Taylor, p/t clerk, office of aging, grade 6, pending the outcome of her background check, effective October 23, 2012. Commissioner Rudy seconded the motion. Motion carried.

Based on the recommendation of David Yeingst, Warden, Commissioner Naylor made a motion to approve the hiring of Michael Rayson, Dennis Wilson, Kevin Reisinger and Timothy Winter as p/t C.O's, \$16.40 hourly, effective October 29, 2012, pending the outcome of their background checks. Commissioner Rudy seconded the motion. Motion carried.

Public Comments: Comments were made regarding the picketing in Newport regarding the police department.
