**Public Comment:**

Commissioner Rudy made a motion to approve the Pilot Agreements with amended changes by the Solicitor for Roger and Brenda Watson and Charles Burd, property owners in Howe Township whose selected property sites have been designated as Keystone Opportunity Zone sites in Perry County. Commissioner Benner seconded the motion. Commissioner Naylor opposed. Motion carried.

Based on the recommendation of the Cumberland /Perry Mh-IDD Board, Commissioner Naylor made a motion to approve the 2018-2019 Provider Service Agreement for Intellectual and Developmental Disabilities to Dauphin County Mh/IDD, contract number ID18-0054 in the amount of \$18,131.00. Commissioner Rudy seconded the motion. All agreed. Motion carried.

Commissioner Rudy made a motion to approve the Agreement with NRG for a Maintenance Services Agreement for the Prison and Veteran's Building for Temperature Controls and software in the amount of \$6,490.00 effective December 1, 2018 with a continued period year to year until terminated. Commissioner Naylor seconded the motion. All agreed. Motion carried.

**Employee Status:** Commissioner Rudy made a motion to accept the letter of Retirement for Kenneth Little, caseworker, C&Y effective October 31, 2018. Commissioner Naylor seconded the motion. All agreed. Motion carried.

Commissioner Rudy made a motion to accept the resignation for Christopher Stroll, p/t dispatcher trainee, 911 effective October 1, 2018. Commissioner Naylor seconded the motion. All agreed. Motion carried.

Commissioner Rudy made a motion to approve the hiring of Carolina Morris, p/t cook, prison effective October 29, 2018 at an hourly rate of \$13.62. Commissioner Naylor seconded the motion. All agreed. Motion carried.

Commissioner Naylor made a motion to approve the hiring of the following p/t dispatcher trainees' effective November 4, 2018 at an hourly rate of \$11.84 hourly. Commissioner Rudy seconded the motion. All agreed. Motion carried.
