ORDER

AND NOW, September 5, 2007, in furtherance of the Code of Civility adopted by the Supreme Court of Pennsylvania on December 6, 2000, and the duties of the Court and counsel there under, it is **HEREBY ORDERED** that:

1. No one shall be permitted into the courtrooms of this Judicial District unless dressed appropriately (e.g. no athletic shorts, short shorts, sweatpants, tank tops, halter tops, bare midriffs, rubber flip-flops, apparel displaying offensive language and/or graphics, etc.)
2. The exclusion of a party from the courtroom because of inappropriate dress shall not excuse such party's failure to appear when that party's case is called by the Court.
3. All communications devices are barred from the courtroom, with the exception that law enforcement personnel may have communication devices that provide them with an inaudible alert to an incoming message. Any person whose communication device emits an audible signal during court, shall have the device removed by the Sheriff and returned only at the conclusion and/or recess of court.
4. No food, beverages, or gum shall be permitted in the courtroom.
5. Nothing in this Order shall limit the inherent powers of the Court to control the courtroom.
